Re: Chene Drive, Jefferson Drive, and Iroquois Drive Reconstruction Program, City Project 22-391

Dear Resident:

Sterling Heights City Council has approved the reconstruction of a portion of Chene Drive, Jefferson Drive, and Iroquois Drive by Galui Construction. Construction is tentatively set to begin with pavement cutting during the week of June 27 (weather permitting). Traffic will be reduced to one lane in the work area during the project. Alternative exits from your neighborhood include Engleside Drive and Coplin Drive. The grass between the street and sidewalk and your private driveway approach are not included in the repair and shouldn't be disturbed. However, any areas disturbed by the contractor will be restored at the end of the project, including sprinkler repairs.

The project will have 3 phases (see the back side of this letter for more info), and you'll be given written notice at least 24 hours prior to the start of work in your phase. If you are adjacent to a replacement location, you won't be able to access your driveway for the approximately two weeks it will take to complete that phase. Please have your vehicles moved outside of the designated work area upon receipt of this notice. Please do not drive on the fresh concrete until barrels are removed by the City (usually about seven days). This will allow the concrete to become strong enough to tolerate vehicles.

During the project, please place your trash in approved trash/yard waste bags only (avoid trash cans), and it will be picked up by the contractor or GFL on your normal refuse collection day. Temporary mailbox stations will be established to allow continuous access by the postal service. These locations are shown on the back of this letter.
