Guidelines for Street Closing for Block Parties

1. No "main through", connector or long streets can be closed.
2. The Traffic Safety Bureau, (586) 446-2920, must first approve requests for street closings before petitions are circulated. Petitions must be submitted three weeks prior to date of street closing.
3. It is required that a petition be signed by ALL of the residents of the street to be closed. If one resident does not wish that the street be closed, permission will not be granted.
4. All petitions must have the name, address, and phone number of the person(s) in charge of the party.

General Rules

1. Street closings are limited to six (6) hours and are not to exceed 10 p.m.
2. Noise must be limited as to not disturb residents of adjoining neighborhoods.
3. The person(s) in charge is responsible for removal of all debris.
4. The D.P.W. will provide the necessary barricades which will be left at the home of the person in charge of the event. The barricades will be picked up the first working day following the date of the street closing.
5. A clear route must be maintained down the street to enable emergency vehicles to respond if necessary.
